fatima Project: Training material—The Human Rights Game

The project aims to increase the capacity within ethnic minority NGOs by training people from ethnic minority NGOs and equipping them with training materials in human rights and rights of women and children.

The training material that has been developed by the project partners is:

- 1. "Human Rights in Practice" Game (available in 12 languages)
- 2. Handbook for coaches (available in 12 languages)
- 3. Methodological tools (e-library) available on the project's website (available in EN, GR, SE & PT)
- 4. Manual for NGO capacity building

The training material has been presented and delivered to more than 60 NGOs from all partner countries and is being used in national pilot activities.

Training of Trainers Workshop


On Human Rights Day, the 10th of December, representatives from the United Kingdom, Sweden, Portugal and Greece met on a two-day Training of Trainers Workshop. They overviewed the project tasks, the training material and the role of ethnic minority NGOs in the upcoming pilot activities.

Main steps of the Project

The project has been progressing through the following steps:

- ♦ Human Rights Game printing and On-line library training material for education & social dialogue on human rights with focus on women and children rights.
- ♦ Training of Trainers in Newcastle—upon-Tyne. The seminar took place on 10-11 December 2015. During the 2 days seminar, representatives from the United Kingdom, Sweden, Portugal and Greece overviewed the project tasks, the training material and the role of ethnic minority NGOs in the upcoming pilot activities.
- ◆ Training in 15 ethnic minority NGOs in each participating country in the use of the training material. The goal of the training workshops was to educate coaches in order for them to be able to conduct the project's pilot activities.
- ◆ Transnational partnership: 15 NGOs from each country are connected to each other through the website of the project to share and exchange experiences.

FATIMA Final Conference

The Final Conference will take place in 26-27 April at Örebro University. The conference will be dedicated to violence, honour, and the hope for gender equality futures free from violence and oppression.

Project Progress:

15 ethnic minority NGOs in each country (Greece, Sweden, Portugal, UK) have participated in the training on capacity building and on the use of the training material. After the training of trainers, the coaches have formed groups of people to test the training material and "play the game". Groups of 10-15 people will participate in 10-12 study cycles and will have the opportunity to learn their rights and increase their self-confidence and self-esteem by playing a game. The objectives of the pilot activities are:

- ♦ the participants learn about the fundamental human rights and the internal value of all people
- ♦ the participants understand the integration laws in Sweden, Greece, Portugal and the Great Britain
- ♦ the participants understand what organizations and resources are available in working with preventing patriarchal abuse and oppression in the home.

During the next phase of FATIMA project all partners will implement the following activities:

- → Pilot activities of NGO's
- → Testing of training material
- → Monitoring of the participants' progress
- → Final workshops in the end of the pilot activities
